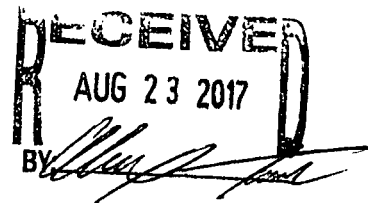



6. The remainder of the Court's file and progress docket shall otherwise remain available to the public.
